QUESTIONS:

1- How did you get into criminal law?

I was always interested in criminal justice policy throughout school, which led me to law school. I gravitated towards criminal law with that background in mind after getting a Master's degree in criminal justice policy.

2- What type of cases do you enjoy defending the most and why?

I enjoy representing clients who have addiction and mental health issues. I always found that background interesting from a policy perspective and find that there are glaring gaps in the way that our system in Canada addresses accused who suffer from mental health and addiction issues. I think it's important for those individuals to have counsel who can help them navigate and understand the system and connect them to resources.

3- How did the practice of criminal law change you?

Practicing criminal law, and defence in particular, made me become more passionate about the social aspects of client work. A huge aspect of criminal defence involves caring about the social needs of your client, like housing, mental health care, and access to affordable services in the community. It really helped me understand the responsibility that comes along with the practice beyond just working on black letter law every day.

4- If there is one thing only you would like to see change in criminal law, what

would it be?

I'd like to see Crown Attorney's become more compassionate and patient, and the system in general become more cognizant of the holistic issues that those who come in contact with the system face. I think we have a chance as criminal lawyers, both Crown and defence, to help accused who come in contact with the system to ensure accused persons don't come back into contact with the system after they access our services. In a perfect world, I'd like to see that change.

5- What advice would you give to your younger self when you first started

practising criminal law?

This is hard, because I just started practicing! I think I would tell myself to trust the process, and that as hard as it can be to be new at the profession, learning takes time.
